"The recent killings of Pakbased terrorist Paramjit Singh Panjwar, UK-based Avtar Singh Khanda and Canada-based operational head of Khalistan Tiger Force, Hardeep Singh Nijjar, have evoked sharp reactions from Sikh radicals and pro-Khalistan elements or PKEs. They have alleged involvement of Indian agencies for these killings and threatened to take revenge," an official said, citing the threat assessment report.

tions of the Manipur High Court, the state government issued an order conditionally restoring broadband internet services. However, mobile internet services continue to be suspended.

Hearing a set of petitions seeking the restoration of internet services, the HC had on July 7 directed that the state authorities conduct physical trials to explore the possibility of providing mobile internet services to certain whitelisted mobile numbers. The authorities had submitted to the court that the trial had been conducted and a report to this end submitted by service providers stated that there was no data leakage to any other numbers that are not whitelisted.
