Further, on the receipt of your consent in this regard, the Board has inducted you as a member of the Risk Management Committee of the Company w.e.f 23<sup>rd</sup> September, 2025.

#### 3. Role & duties

- a. Your role and duties as an Independent Director would be as provided in the Companies Act, 2013 read with other applicable laws / rules / agreements.
- b. There are certain duties prescribed for all Directors, which are fiduciary in nature. As member of the Board you along with the other Directors will be collectively responsible for such duties as under:
  - i. You shall always act in accordance with the articles of the company.
  - ii. You shall act in good faith in order to promote the objects of the company for the benefit of its members as a whole, and in the best interests of the company, its employees, the shareholders, the community and for the protection of environment.
  - iii. You shall exercise your duties with due and reasonable care, skill and diligence and shall exercise independent judgment.
  - iv. You shall not involve in a situation in which you may have a direct or indirect interest that conflicts, or possibly may conflict, with the interest of the company.
  - v. You shall not achieve or attempt to achieve any undue gain or advantage either to yourself or to your relatives, partners, or associates.
  - vi. You shall not assign your office and any assignment so made shall be void.
- c. As an Independent Director you shall abide by the Code of Independent Director as enumerated under Schedule IV of the Companies Act, 2013. For your reference Schedule IV is attached herewith this letter.
- d. You shall not hold office as an Independent Director in more than seven listed entities at any given time. Notwithstanding the foregoing, in the event that you are appointed as a Whole-Time Director or Managing Director in any listed entity, you shall not serve as an Independent Director in more than three listed entities.

### 4. Confidentiality

You are expected to maintain the confidentiality of the proceedings of the Board and Committee meetings. You shall not disclose confidential information in your possession unless expressly approved by the Board or required under any law.

#### 5. Code of Conduct

The Company has in place a Code of Conduct to be observed by Directors and Senior Employees. The Code of Conduct is also placed on the Company's web site. As a Director, you are required to comply with company's Code of Conduct. For your reference the Code of Conduct is attached herewith this letter.

# 6. Inspection of the terms and conditions of appointment

The terms and Conditions of your appointment as an Independent Director are open for inspection by any member at the Registered Office of the Company during normal business hours and the same will also be posted on the Company's website, in terms of Clause IV(5) and (6) of Schedule-IV of the Companies Act, 2013.

## 7. Remuneration

As a Non-Executive Director, you shall be paid sitting fee for attending the meetings. At present, sitting fee is Rs.25,000/- per meeting.
